- i. Providing useful inputs in outlining scope, designing processes, preparing questionnaires and tools for the process of social audits in order to develop the final approach of social audit for schemes under D / o Social Justice Empowerment;

ii. Contributing in designing of an effective Management Information System (MIS)/Webpage in D/o Social Justice Empowerment through their experience and knowledge;

iii. Support during trainings as resource persons for enhancing capacities of social justice cell members of Social Audit Units;

iv. Visiting district social justice assembly and participating in activities being conducted during this process for their valuable suggestions to improve quality of social audits as and when requested for the same by NRCSA-NISD;

v. Monitoring of the social audit process and subsequent action taken on the Social audit findings as and if desired by D/o Social Justice Empowerment; &

- vi. Participating in workshops to develop advisory for action and reviewing the process at National Level as and when desired by NRCSA -NISD.
- 4. Any other eminent experienced person can be called to participate in this meeting as per the need, for seeking advice as and when felt by the D/o SJE after approval from the competent authority.
- 5. The members of SAAB, who are from academic institutions and NGOs and who shall be travelling from outstations to attend the meetings or participate in any activities listed above, shall be eligible for economic class air travel and their logistic shall be arranged or reimbursed by NRCSA-NISD.
