The Social audit plan is detailed in a scheme titled 'Information, Monitoring, Evaluation and Social Audit '(I-MESA) and for this purpose a National Resource Cell for Social Audit (NRCSA) has been set up in NISD, New Delhi under this program for coordinating social audits of D/oSJE schemes by SAUs, training them and monitoring the progress of the audit.

For this Financial year (2023-24) five schemes have been identified for social audit i.e; Integrated Rehabilitation Centre for Addicts under NAPDDR, Senior Citizen Homes under AVYAY, Modal Villages, Hostels (Babu Jagjivan Ram Chhatrawas) & Grant in aid under PMAJAY, Schools under SHRESTHA, & Hostels for OBC students under YASASVI scheme. The overall target for conducting social audit for this year is 1054 (Attached State wise list of Districts and Target).

The training of 274 Social justice cell members from each State Social Audit Units have already been completed. These trained SJC members will be conducting the social audit of these schemes. It is therefore requested to kindly submit the calendar as per the attached guidelines in prescribed format attached herewith within seven days. The budget for the same is being processed for approval which includes the travel expenses of the participants who have undergone 10 days regional training.

An online orientation has also been planned jointly with the State Social Welfare Department in the coming days. Please contact our team for any clarifications required on this matter.
