A review of the National Resource Cell for Social Audit- DoSJE, was held at 11:00 A.M on 1<sup>st</sup> June 2023 under the chairmanship of the Secretary, SJE on the 6<sup>th</sup> floor, New Conference Hall.

The meeting began with a discussion on the origin and the mandate for social auditing of schemes. The representatives made a detailed presentation on the objectives, scope, guidelines, functioning, and way forward. A detailed discussion was held on each subject. The following decisions were taken:

- i. A need for detailed scheme-wise standards for auditing was recognised. The JS & FA, CEA, and DDG will convene a meeting with the socialaudit cell to strategise the plan of action for 2023-24 and identify the schemes that need to be brought under the purview of social audit.
- ii. The nature of work done by the PMUs and the social auditing teams was understood and some synergies were identified. Secretary suggested bringing convergence in the functioning of both teams. The details be worked out by JS (RC) and Director, Nisd.
- iii. Secretary suggested AS to pursue the matter on final UCs, with MoRD/ NIRD.
- AS, DDG, and NIC teamswill convene to facilitate the development of MIS on the website.
- v. It was suggested that the matter of appointment/ renewal of staff be taken up by DDG.
- vi. Secretary has asked JS & FA to cross-verify the mandate of SAUs for support to DoSJE.
- vii. It was suggested that the matter concerning SAUs be added as an agenda point for the proposed meeting with Secretary, MoRD.

The meeting ended with thanks to the chair.
